Treasurer's Report

Marlena walked us through the latest report. Happy's Circus made £3495 profit! Swimming is making good money – Spring term £2.6k, Summer £3.5k not including the intensive courses. Tea Towels £300 profit but the invoice is being corrected and some to sell at the fair.

Recent Events

- Circus event went very smoothly, the weather was kind and the bar was drunk dry of wine and fizz. Happy's Circus is already booked out for summer 2024. There is an option for weds 16th July 2025 or we investigate 2026 and another provider for 2024/25. Decision is to book 2025 circus date. Think in advance about summer fair date. Think about when we want the circus in 2026 what dates are available June? An alternative for 2024 picnic with a bar (and toilets), perhaps.
